- Reverted back regulation changes made on February 3, 2017. The changes were to better clarify recordkeeping and retention requirements. The reason the changes were reverted back was due to the original changes being overturned by the Congressional Review Act.

- OSHA has been updated to reflect new OSHA reporting requirements. Previously, employers had to report all work-related fatalities and work-related hospitalizations of three or more employees to OSHA. Employers now have to report to OSHA:
 - All work-related fatalities
 - All work-related inpatient hospitalizations of one or more employees
 - All work-related amputations
 - All work-related losses of an eye
